### How To Enter:

- Email photo as an attachment to klynch@nssga.org
- The body of the email must include the photographer's name and contact information.

### Contest Rules:

- Your company must be a current member of NSSGA to enter.
- Deadline for entries is Oct. 31, 2022.
- Each participant may submit one photo relevant to this year's theme.
- Photos are accepted in the following digital format: JPG files with at least 300 dpi.
   Only high-quality digital images are eligible for entry.
- The submitted photos must be the photographer's original work.
- Photos do not need to be taken within the contest timeframe to be eligible to win.
- Photos with date stamps or photographer's name on the photo will be disqualified.
- Photos that have been digitally altered beyond standard optimization (cropping, reasonable adjustments to exposure, color, and contrast, etc.) will not be chosen. Any images not meeting these specifications will be disqualified.
- NSSGA will at its sole discretion determine eligibility. NSSGA reserves the right to
  reject and disqualify any images that are considered inappropriate. By entering this
  contest, you represent that you have all rights to grant, and do hereby grant NSSGA a
  royalty-free, worldwide, perpetual, non-exclusive license to use, publish, display,
  distribute, reproduce, edit, adapt and create derivative works of the submitted
  photograph, in whole or in part, in any media now known or hereafter discovered,



including in use on websites, in publications and for promotional purposes, without compensation or prior notice to the participant, his or her successors or assigns, or any other entity.
